## OSHA's HEPA Requirements

OSHA requires a High-Efficiency Particulate Air (HEPA) vacuum for **housekeeping and vacuuming drill holes**. It is advised that each construction crew has at least one HEPA vacuum on site, such as the HEPA BackPack DustlessVac (Model 15505).



**NOTE:** For some jobs, OSHA requires personal respiratory protection of APF 10 - 25 (regardless of dust control systems).
